Community Sessions:

In August, we had over 10 community sessions! From student organizations to indigenous communities, and healthcare professionals to grassroots women and girls, we had people of all ages and social backgrounds congregating over the course of these days. Sessions were targeted towards raising Awareness on Sexual and Reproductive Health Rights for Young Girls and women in KP. An increase in awareness on sexual and reproductive health leads to better access to health services.

Champions follow-up Meeting:



August is all about dealing with post COVID situations.

During the follow-up meeting Champions discussed the impact of COVID-19 on education in their respective communities. They shared that accessibility to online classes and usage of electronic gadgets was an issue for most of the students from rural areas. Students lost their interest in studies due to disconnection from studies for a long period of time. Unlike Private, most of the champions stated, Government schools lack behind in development of proper strategy for re-opening of schools.

They discussed their activities during lockdown. Most of them distributed ration bags to help people in times of financial crises and initiated tuition classes free of cost for students.

Some follow-up Meetings with Service Providers:

In August Da Hawwa Lur Team Conducted three Follow-up meetings with our service providers which included NADRA, HMC and District Courts. To provide services to the women, girls and transgender community at grassroot level in KP Da Hawwa Lur aims at building strong connections with different government and private sectors for the provision of services to the marginalized communities.

- At district courts Ms.Nihal discussed the nature of the cases referred to and by DHL. The cases will be referred from DHL to pro bono lawyers and legal firms. The lawyers will sign the MoU and provide their legal services. Also to provide medical support to the Drug addicts and HIV patients.
- At NADRA Ms. Risalat discussed about the MoU between DHL and NADRA for easy registration of Transgender CNIC and better referral mechanism. Services provided to transgender by NADRA and social welfare department were discussed briefly. That both the department would work in collaboration as a social welfare department will help to develop a list after proper survey and that very lists will be sent to NADRA for identification.
- At HMC Ms.Farhat asked for a representative from HMC to be present during awareness sessions conducted by Da Hawwa Lur for transgender community to talk about importance of health and negative impacts of HIV . A proper hard file to be submitted by Da Hawwa Lur indicating their activities,provision of services to transgender community and status of NOC for future collaboration. A representative from PACP will attend the awareness session whenever needed.
